Florida's Infrastructure Assets

Florida's has one of the most extensive multi-modal transportation systems in the world—giving you the ability to move your product anywhere in the world. So the only thing easier than operating your business in Florida is moving your product out.

- Florida's seaports contribute \$117.6 billion in economic value to the state, according to Florida Ports Council.
- Florida maintains the second-largest foreign trade zone network in the country.
- Once goods arrive in Florida, shippers and logistics providers can choose from approximately 122,000 miles of highway systems and 3,000 miles of freight rail to move shipments to their final destination.
- In addition to hosting the **third-largest cluster of logistics** companies in the country, Florida offers a **vast network of inland distribution centers** that supports the state's airports and seaports.

Florida Ports Council

The Florida Ports Council is the professional association of Florida's 14 seaports, providing advocacy, leadership and research on seaport-related issues before state and federal government. Florida's ports support nearly 900,000 jobs in the state and contribute \$117.6 billion to the state's economy each year.





Global Connectivity

With its state-of-the-art infrastructure, Florida enables the efficient movement of goods, people, and data across the globe. The state's multimodal transportation system includes **20 commercial airports**, 15 deepwater seaports, advanced highway and rail networks, modern fiber-optic telecoms networks, and several major highspeed data transmission hubs. Florida is also **home to one in five U.S. exporters**, with the combined annual value of goods and services exports exceeding \$100 billion.

Gateway to Latin America

Florida is the Americas' commercial crossroads. Due to its strategic geographic location, advanced infrastructure, access to finance, and multi-cultural and multi-lingual workforce, Florida serves as the principal gateway to Latin American and Caribbean markets for both U.S. and overseas companies and accounts for about a third of total U.S. trade with Latin America and the Caribbean.

International Business Hub

Florida is host to several thousand affiliates of companies based outside the United States, including hundreds of hemispheric or regional corporate headquarters. Besides corporate HQ's, many international firms have located other kinds of facilities in Florida, such as manufacturing plants, R&D labs, sales and marketing offices, logistics and distribution operations, and customer service centers, to take advantage of easy access to markets worldwide.

Incentives





Florida offers incentives for all types of businesses, from corporate headquarters to manufacturing plants and service firms. These include:

Brownfield Incentives

Businesses that cleanup and redevelop an existing brownfield site are provided with generous financial incentives, regulatory benefits, technical assistance, and liability protection.

Advantages include:

- A \$2,500 Job Bonus Refund for each new job created
- · Expedited permitting
- · Increased State Loan Guarantee
- Voluntary cleanup tax credits

Capital Investment Tax Credit

The Capital Investment Tax Credit is used to attract and grow capital-intensive industries in Florida. It is an annual credit, provided for up to twenty years, against the corporate income tax.



High Impact Performance Incentive (HIPI)

The High Impact Performance Incentive is a negotiated grant used to attract and grow major high impact sectors in Florida. These include:

Clean Energy, Corporate Headquarters, Financial Services, Logistics, Information Technology, Advanced Manufacturing, Transportation Equipment Manufacturing, and Semiconductors;

The company must create at least 50 new full-time jobs and at least a \$50 million cumulative investment in a three-year period (if an R&D facility, 25 jobs and \$25 million).

- Tax Exemption for Research & Development Equipment
- Urban Job Tax Credit Program

Incentives





Florida also offers a variety of training programs to support new and expanding businesses to hire talent in the state.

CareerSource Florida

Many of these training programs are delivered by CareerSource Florida, the statewide workforce policy and investment board.

With support from the Department for Economic Opportunity, 24 local workforce development boards and 100 career centers throughout Florida, CareerSource Florida advances policies and initiatives that enhance worker productivity and business competitiveness.

Its notable training programs include the **Quick Response Training Program** and the **Incumbent Worker Training Program**.



Quick Response Training

This program provides grant funding for customized training to new or expanding businesses. The program is flexible and structured to respond quickly to meet business training objectives.

A local training provider – community college, area technical center, or university – is selected and available to assist in the application process and program development or delivery.



If the business has a training program in place, a state training provider will supervise and manage the training program and serve as the fiscal agent for the grant funds.

Incumbent Worker Training

This program provides employers with funds to train currently employed workers in an effort to keep their firms and workers competitive. The program addresses retraining to meet changing skill requirements caused by new technology, retooling, new product lines, and new organizational structuring.
